# F. NOTICE OF FUNDING OPPORTUNITY PRESENTATIONS AND RANKINGS

The Notice of Funding Opportunity (NOFO) for the 2024 Events and Activities was launched the 1<sup>st</sup> of September, 2022. The new format allows for a fair and balanced opportunity for all to request funds. This is the second of the two (2) cycles of funding for FY 2023/2024. Each applicant will go before the Marketing Committee to present their requests. The Marketing Committee will then rank each application and make recommendations to the ECVA Board of Governors.

Committee Chair Anderson explains that during the August 2023 Meeting the Board of Governors set the available funding for this fiscal year cycle to \$30,000 for fall applications & \$30,000 for spring applications, making the overall goal for the Notice of Funding Opportunity (NOFO) process to increase the overall visitors in Elko, ncrease hotel nights, meals and restaurants, spending in the community and generally bringing people from outside the area. Committee Chair Anderon explains that the reason that there is more than \$30,000 to recommend this application period is because not all funding was used during fall awards, a total of \$14,500 was rolled over bringing the total budget for this cycle to \$44,500. Committee Chair Anderson stated that the recommendations made from the Marketing Committee will then go before the ECVA Board of Governors at the next meeting for approval.

Committee Members began discussion and taking scores. Committee Chair Anderson called a recess at 10:15AM. Mrs. Cromwell and Mrs. Morales took the score sheets to tally up the scores.

Tom Lester left the meeting at 10:31AM.

Mrs. Cromwell and Mrs. Morales returned with the votes and the meeting resumed at 10:40AM. Mrs. Cromwell explained the tally scores and how they ranked in order stating the total for all requests amounted to \$59,000 so there will have to be some adjusting due to having \$44,500 budgeted. Committee Member Burrows suggested that they use the guideline and go through the recommendations to stay in range. Committee Members discuss.

Committee Member Petersen moved to approve removing the Elko County Twin+Day. Committee Member French seconded. Motion carried (5-1) Committee Member Burrows abstained. Committee Members continue discussion.

Committee Members made funding recommendations as follows;

- \$5,000 for the National Basque Festival
- \$3,000 for the Ruby Mountain Race Series
- \$5,000 for the Stampede Country Kickoff Concert
- \$3,000 for the Haunted Commercial Hotel
- \$8,000 for the Elko County Fair
- \$4,500 for the Rides & Rods Elko Classic Car Show
- \$500 for the Feral Production Barrel Racing
- \$4,000 for the Gold Rush Challenge
- \$5,000 for the Ruby Mountain Balloon Festival

Committee Member Burrows moved to approve recommended amounts as discussed to go before the Board of Governors for approval. Committee Member Petersen seconded. Motion carried (6-0)

Mrs. Gilbert stated that they also have access to digital platforms, digital billboards and they also network with other media outlets throughout the entire region. Mrs. Cromwell asked Mrs. Gilbert to provide her with this information on where they can expand to, and she can get it to the NOFO applicants.
