VII. NEW BUSINESS

A. Discussion and consideration for possible action regarding Venue Fee Waiver sponsorship for First Nevada in the amount of \$2,558.75 for the dates of November 22nd and 23rd, 2024. First Nevada is a non-profit organization promoting First Robotics Programs and STEAM education initiatives in Nevada. First Nevada held last year's competiton at the ECVA. The lobby, auditorium, and other rooms were utilized. Sponsorship was \$2,225.00. Young students from Elko and surrounding communities participated in this event.

B. Discussion and consideration for possible action regarding receipt of a discount of \$3,500 for the UNR, School of Medicine, 2024 Rural Nevada EMS Conference. This is a four-day annual event that significantly enhances the skills and knowledge of Nevada's EMS professionals. Drawing 250-300 attendees from across Nevada and neighboring states. Attendees include Nevada State EMS, local mines, vendors, and sponsors. The 2023 Rural Nevada EMS Conference was held at the ECVA. They received a \$3,500 discount towards their rental of the facilities.
